

ORDINANCE NO. 9-15-2023

AN ORDINANCE REGARDING THE DESIGNATION OF HANDICAPPED PARKING SPACES IN THE TOWN OF TROY, PERRY COUNTY, INDIANA

WHEREAS, the Town Council of the Town of Troy, Indiana has the authority to regulate parking along town streets and alleys; and

WHEREAS, the Town Council wishes to provide for the designation and enforcement of handicapped parking spaces along town streets and alleys.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Troy, Indiana as follows:

1. The Town Council may designate certain parking spaces within the town as reserved or restricted for the handicapped, and when spaces are so reserved or restricted by a resolution of the Town Council duly entered of record, and when official signs are so erected, indicating those restrictions or reservations, no persons other than the handicapped shall park any vehicle in that space in violation of the official sign designated reserved or restricted area.

2. Any parking spaces designated as handicapped parking by the Town Council shall be designated as prohibited parking areas for all vehicles except those specifically marked by appropriate licensing as for handicapped persons. It shall be unlawful for any person to park, or permit to remain standing, any motor vehicle at those locations unless that vehicle is designated as licensed for a handicapped person.

3. Any person who requires or requests a handicapped parking space may apply to the Town Council.

4. The Town Council shall review any applications for handicapped parking spaces and approve or deny the request after review of the need of the applicant and the parking space requested. The Town Council may impose its own terms and conditions on the granting of a handicapped parking space. Violations of those terms and conditions may result in the revocation of the grant of a handicapped parking space.

5. The Town Council shall impose a fee of \$75.00 for the cost of the handicapped sign and installation of said sign.

6. The Town Council may remove a handicapped parking designation if the facts and circumstances warrant such removal. Further, town officials may remove a handicapped parking designation at the request of the person who requested the handicapped parking space or at the request of a member of that person's immediate family.

7. Parking of a vehicle by any person in a space reserved hereunder without a visible permit or special registration plate showing such parking to be authorized shall be unlawful and shall subject the owner and/or driver of the vehicle so parked to a penalty of \$50.00 for the first violation and \$75.00 for each subsequent violation, and all penalties are

to be enforced as provided by the general penalty provisions of the Troy Town code. Violators shall be responsible for any towing expenses as well as payment of any applicable impoundment fees.

8. The Town Council hereby reaffirms its earlier designation of the following two (2) handicapped parking spaces in the Town of Troy, Indiana: A parking space in front of 400 Main Street, Troy, Indiana and a parking space in front of 228 Harrison Street, Troy, Indiana.
