Deputy 2 \$15.00 per hour as needed.

Not to exceed Budget Annual amount for Deputy Clerk.

Council salary will be paid Semi-annual.

President \$750.00

Council members \$650.00

Marshall salary increased to \$16.00 per hour to be competitive with nearby Cities & Towns.

Street Superintendent \$19.00 per hour. \$1 per hour increase.

Accounting Manager \$16.00 per hour.

Full time Utility Clerk \$14.00 per hour.

It is noted in Salary Ordinance that all wages listed at the maximum with minimum rate being minimum wage for new hires.

Community Crossings-2 of 3 submitted was approved for road pave project. \$47,493.75. Overlay = \$13,143.75. Total=\$60,637.50.


Citizens:

Email from Melissa Carter. Concerned about noise when construction starts near her home. Ordinance does not specify what time noise can start. Council to review ordinance.


NEW BUSINESS: Bret Kleeman noted he does not see Marshal in town. Council requested to see his dispatch log.

OLD BUSINESS: Follow up on Smith Residence after continued requests to clean property on Washington St.


